**STATEMENT OF CAMPAIGN EXPENSES FOR ELECTION TO BOARD OF EDUCATION**

- Initial Statement - must be filed at least 30 days before the election.**
- Second Statement - must be filed on or before the 5<sup>th</sup> day preceding the election.**
- Final Statement - must be filed within 20 days after the election.**

Section 1528 of the Education Law requires that all candidates for election to a Board of Education file sworn statements of campaign expenses.

The filing must set forth all moneys or other valuable things which have been paid, given, expended or promised for or on his/her behalf, with his/her approval, by any person, firm association or corporation for the purpose of aiding in his/her nomination or election or to defeat any other candidate in the election.

An itemization is necessary if expenditures exceed \$500. When the candidate's only expenditures were for personal expenses which, when taken together with the total expenditures incurred by others on his/her behalf, and with his/her approval, are under \$500, a sworn statement must be filed indicating that his/her election expenditures did not exceed \$500.
